

## Sejha għal espressjoni ta' interess għal Ambaxxaturi tal-Qari fuq bażi ta' kuntratt għal servizz

### Harsa ġenerali:

L-Aġenzija Nazzjonali tal-Litteriżmu qed tfittex personalitajiet magħrufa lokali fuq bażi ta' kuntratt għal servizz biex jipprovdu sessjonijiet ta' qari għall-gost. L-Ambaxxaturi tal-Qari jistgħu jkunu atturi, awturi, ġurnalisti, kantanti, preżentaturi, sportivi, xandara jew żeffiena.

Il-kandidati magħzula se jipprovdu bejn 12-il siegħa u 64 siegħa ta' servizz, mifruxa fuq perjodu ta' 8 xhur minn Mejju sa Diċembru 2024, bil-possibilità ta' tiġdid għal perjodu ulterjuri sugġett għal prestazzjoni tajba. Huwa previst li kull attività ta' qari tiegħu madwar 3 sigħat ta' servizz. Ir-rata tal-ħlas hija ta' €12.67 fis-siegħa, eskluża l-VAT jekk applikabbli. Se jingħata ħlas ukoll għall-preparazzjoni tas-sessjonijiet.

- Atturi, awturi, ġurnalisti, kantanti, preżentaturi, sportivi, xandara jew żeffiena li huma magħrufa u stabbiliti.
- Profiċjenza għolja fil-qari, fit-taħdit u l-komunikazzjoni bil-Malti u/jew bl-Ingliż.

Tingħata preferenza lil kandidati li diġà għandhom esperjenza jagħmlu sessjonijiet ta' qari tal-programm tal-Ambaxxaturi tal-Qari.

## **Call for expression of interest for Reading Ambassadors on a contract for service basis**

### **Overview:**

The National Literacy Agency will be recruiting local personalities on a contract for service basis to provide interactive sessions. Ambassadors can be actors, broadcasters, authors, dancers, footballers, journalists, or presenters.

The eligible candidate/s will provide between 12 hours and 64 hours of service, spread over a period of 8 months from May to December 2024, renewable for further periods subject to satisfactory performance. It is envisaged that every reading session will last approximately 3 hours. The payment rate is €12.67 per hour, excluding VAT where applicable. Remuneration will be provided for session preparation.

The selected service providers will be accountable to the CEO of the National Literacy Agency and/or his/her delegate. Full-time employees of the Agency are not eligible.

Eligible applicants will be requested to sit for an interview.

### **Duties and responsibilities:**

1. Prepare and deliver effective reading sessions for children and their educators. Parents/caregivers may be present on some occasions.
2. Maximum high standards of professional practice and behaviour.
3. Maintain a collaborative working relationship with all relevant stakeholders to ensure quality and timely services are provided.

### **Objectives:**

1. Support the development of literacy among children through reading/storytelling.
2. Promote the love and enjoyment of books through high quality reading/storytelling sessions.
3. Ensure full language immersion in either Maltese or English during every reading/storytelling session.

### **Eligibility criteria:**

- Actors, broadcasters, authors, dancers, footballers, journalists, and presenters who are well known and established.
- Excellent fluency and communication skills in Maltese and/or in English.

Preference will be given to candidates that have previous experience delivering sessions as part of the Reading Ambassadors programme.
